CADV PROVIDES COUNSELING TO HELP EDUCATE AND HEAL THOSE IMPACTED BY INTIMATE PARTNER VIOLENCE (WOMEN, MEN, TEENS AND CHILDREN) AND THOSE WHO CHOOSE TO PERPETRATE. THE REQUIREMENTS FOR ACCEPTANCE AND PARTICIPATION IN THE PROGRAM ARE THE SAME FOR EVERYONE REGARDLESS OF RACE, COLOR, NATIONAL ORIGIN, SEXUAL ORIENTATION, AGE, GENDER, DISABILITY, BELIEF SYSTEMS, OR SPIRITUAL-BASED PRACTICES AND ARE BASED ON PROGRAM REQUIREMENTS AND FUNDING GUIDELINES.
